

## Visa Spend and Win 2022 FIFA World Cup Qatar™ Promotion in Qatar

### Terms & Conditions

**1) Promotional Overview.** Participants in the “Visa Spend and Win 2022 FIFA World Cup Qatar™ Promotion in Qatar” (the "**Promotion**") will be deemed to have accepted these terms and conditions ("**Terms & Conditions**") and agreed to be bound by them when participating in any element of this Promotion. Participants automatically lose their eligibility to participate in the Promotion upon violation (or attempted violation) of these Terms & Conditions or the spirit of these Terms & Conditions. ### **2) Entry Requirements**

- a) All persons aged 21 or over, who possess full legal capacity, hold a valid Visa credit, debit card issued from a financial institution in Qatar ("**Eligible Visa Card**"), and are legal residents of Qatar at the time of making a Qualifying Transaction (defined in section 3 below), will be eligible to participate in the Promotion. An otherwise eligible participant between the ages of 18 and 21 may be required to furnish parental or guardian consent before he or she may participate and/or claim any prize on the same terms.
- b) Employees, officers, directors, agents and managers of, together with any other persons specified by law (including immediate family members) as being too closely related to Visa group companies, Arc FZ LLC, Leo Burnett, BBDO, Starcom, Proximity, Mirum or any third party involved in the supply of the Prize (defined below), are non-eligible participants.

  - ii. make a contactless transaction via Tap to Pay using an Eligible Visa Card ("**Qualifying Transaction**").
- b) The number of entries per Participant is unlimited. Each Participant is eligible to win one Prize only. If a Participant wins more than one Prize, that Participant will be entitled to receive the Prize won first.
- c) There is no minimum amount required for each Qualifying Transaction.

The winner will also benefit from Visa Medical and Security support staff.

- b) A confirmation letter will be provided to the winner within 14 calendar days from the date of the random draw. The winner will be required to sign and return this confirmation letter, together with a copy of their ID, within 14 calendar days from the date they receive the letter from the Promoter in order to claim their Prize.
